### Registration

Your registration details will be stored with Holland Quaestor and will not be freely provided to third parties. Your details will be shared with Law@Work because they use your details on behalf of Holland Quaestor for the course, for participant lists, group designations, and so forth. Participation is on a first come, first served basis. If there are still places available two weeks before the course starts, then participants from the waiting list will become eligible. The number of participants will be a minimum of 20 and a maximum of 30.

## Costs

For Holland Quaestor members, the total cost of the course, including exams and catering, is € 5.999.00. For those who are not Holland Quaestor members, the cost are € 6.999.00. The above amounts are exclusive of VAT.

## Cancellation

Cancellation of a registration may only take place by email. Cancellations 10 or more days before the commencement of the session are free of charge.

If you terminate your training after commencement, you will not be entitled to a refund of the fee you have already paid or are still to pay. A refund or partial refund of the course fee is only possible if an interim termination is the direct consequence of a serious illness or calamity, for which Holland Quaestor may require proof in the form of a medical certificate or other documentation. The medical certificate must in principle be provided by the attending physician and must state at least the following: the identity and position of the person issuing the certificate, the identity of the course participant, the cause of this person's inability to continue the training, and the probable duration of this inability.

## Cancellation by Holland Quaestor

If there are too few participants (fewer than 15), Holland Quaestor reserves the right to cancel the course. Participants will be notified of this as soon as possible.

## Invoice

The course fee will be invoiced in two instalments. You will receive the first invoice two weeks before commencement of the course. You will receive the second invoice in February 2020. Both invoices must be paid within 14 days of the invoice date.
